SUBMITTING A VALID PRESCRIPTION FORM

Required Elements of a Legal Prescription:¹

Florida regulations require the following information to be included on prescriptions when prescribing medicinal drugs. Please ensure all requirements are met prior to submitting the prescription. Prescriptions submitted that are missing any of the required information may result in delays in processing the order.

- Name of prescriber
- Address of prescriber
- DEA number of prescriber (if controlled substance is prescribed)
- Patient name
- Patient physical address (if controlled substance is prescribed) P.O. Box is NOT acceptable
- Drug name, strength, and quantity to dispense
- Instructions for use
- Signature of prescriber (original signature is required if controlled substance is prescribed - NO STAMP SIGNATURE)
- Date of issue or date prescription signed

- If the prescription is for a compounded formula, that needs to be indicated on the prescription. A statement explaining that the patient requires the compounded product should be included (e.g, "By submitting this prescription, I acknowledge that after evaluating commercially available drug product options, I have determined that this compounded preparation is clinically necessary for this patient").²

Different prescriptions can be submitted using the following methods:

Non-controlled Rx – FAX or electronic

Schedule III-V – FAX or electronic

Schedule II – Intrathecal use only- FAX or electronic

Schedule II – electronic or hand written (hand written prescriptions must be mailed and received by the pharmacy prior to processing)

Faxed prescriptions must be sent from the doctor's office to the pharmacy. We cannot accept prescriptions faxed to us by the patient. Please include in your fax header information such as the organization name, submission date, and FAX number. Missing fax header information may delay processing due to sender verification.

Email is not an acceptable way to submit prescriptions. We cannot accept prescriptions through email.

Electronically applied signatures are NOT acceptable as legal signatures when prescribing controlled substances unless the prescription is submitted to the pharmacy electronically. Controlled substance prescriptions generated using computer software, printed, and faxed to the pharmacy must have original “pen to paper” signature. Stamps, photocopies, or electronic images of signatures are not acceptable.

Your state may have additional prescribing requirements. Pharmacies are required to follow the regulations of the state where the drug is dispensed AND the state where the drug is shipped.

If the following optional information is available, please provide it to us as it helps our daily controlled substance reporting to the states.

- Patient driver’s license number
- Patient SSN
- Prescriber’s NPI number

AnazaoHealth's 503A compounding pharmacy in Tampa, Florida focuses on patient-specific preparations serving the Wellness, Pain Management and Nuclear Medicine pharmacy markets. The pharmacy is appropriately licensed in all fifty states, the District of Columbia, and selected U.S. territories.

We have a quality oversight program that we believe is a compounding pharmacy industry leader. This oversight program allows us to meet or exceed all USP <797> sterile compounding and USP <795> non-sterile compounding standards. In addition to the USP compounding standards, we perform both internal and external audits to validate our quality assurance processes. Our sterile compounding process involves no fewer than four different validation checks prior to completion of an order and makes extensive use of bar code technology, reducing chance of human error.

In 2014, AnazaoHealth, Las Vegas registered with the FDA as a 503B Outsourcing Facility. Outsourcing Facilities are required to comply with Section 503B of the FD&C Act and the corresponding guidance set forth by the FDA (Current Good Manufacturing Practice - Guidance for Human Drug Compounding Outsourcing Facilities Under Section 503B of the FD&C Act). The cGMP guidance requires proper design, monitoring, and control of manufacturing processes and facilities, and ensures that products are made with a higher-level of quality than what is required by USP <797>.

We have developed a culture that is focused on the quality of products produced. Each person is accountable for maintaining a high level of quality throughout the process.

AnazaoHealth, Las Vegas, is appropriately licensed to ship office use products to most states, District of Columbia and selected U.S territories. (Patient-Specific only in Alabama and North Dakota)

AESTHETICS

Non-surgical pro-active care of the skin



Skin care is a major target of the cosmetic “anti-age” treatment. Young skin is flexible, elastic, smooth and well hydrated. The aging process modifies the skin’s characteristics quite visibly with lines, wrinkles, discoloration, thinning, and loss of elasticity. It is often the skin’s appearance that first makes us aware of our age.

The skin is our largest organ and functions as a protective covering, a sensing organ, an oil producer and an organ of elimination (through evaporation and perspiration, it clears toxins from the body). If any of the structures in the skin are not working properly, a rash or abnormal sensation is the result. The whole specialty of dermatology is devoted to understanding the skin, what can go wrong, and what to do if something does go wrong.

Aesthetics is devoted to treating the dermis (non-surgically) and becoming pro-active in the care of the skin.

It is important to protect the skin against damage to maintain its elasticity, appearance and overall health. Preventive methods include a healthy diet, supplements, daily moisturizing,

sunscreens, refrain from smoking or excessive alcohol use, and the use of sun filters/blockers against UV light (hats, visors, sunglasses, etc.).

If damage has occurred, treatments in the forms of anti-wrinkle, skin renewal, moisturizing and barrier repair are available to help stimulate the skin’s natural production of collagen to help restore the structure of the skin and smooth out wrinkles. These treatments will usually contain peptides and growth factors.

- **Hydroquinone Lighting Agent** - A topical whitening agent that is considered to be the “gold standard.” Available in a variety of strengths with normal ranges between 2% to 20% and can be combined with Kojic Acid and steroids.
- **Kojic Acid** - A whitening agent created from several fungi species that inhibit the formation of pigment.
- **Tretinoin Solution** - A topical form of Vitamin A used to help the skin renew itself and can be used to treat age spots, liver spots, sunspots, and solar lentiginous.

HORMONE REPLACEMENT THERAPY



The leader in high-quality Hormone Replacement Therapy solutions since 1997

Like all medical therapies, Hormone Replacement Therapy (HRT) may not be appropriate for all patients. Both the benefits and potential risks of the therapy should be discussed with your physician before beginning treatment.

Test for Hormone Levels

Given the current literature and sensitivity to the issues relating to HRT, the practice of routinely prescribing hormones without the appropriate testing for levels is highly questionable. To be accurate, testing should include levels of free (bioavailable) hormones that are more significant indicators of true deficiency or imbalances. Testing choices include serum (blood) or saliva tests.

Prescribe the Right Dosage

Use hormone baseline test results to prescribe hormone replacement therapy to bring your patient's hormones to their optimum targeted levels. Then, monitor hormone levels with periodic follow-up visits and re-testing to assess the effectiveness of the therapy and adjust as necessary.

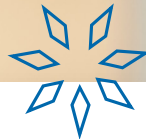
Estrogen Replacement Therapy (ERT)

Estrogen Replacement Therapy (ERT) restores declining hormone levels associated with menopause (women with a personal history or a family history of breast cancer may not be candidates for estrogen replacement). The principal estrogens in a woman are estrone (E1), estradiol (E2), and estriol (E3). Estradiol is the most potent of these estrogens and is produced by the ovary.

Estrone and estriol are both metabolites of estradiol and are less potent, with estriol being the weakest. The most common form of ERT is a compounded formulation of Bi-Est (80% estriol / 20% estradiol) and Tri-Est (80% estriol/10% estradiol/10% estrone). The percentages of estrogen in each compound can be adjusted based upon test results to achieve an optimal patient outcome.

Progesterone Replacement Therapy

Progesterone (P4) is a hormone produced in women by the adrenal glands, the ovaries and in the placenta during pregnancy. In men, smaller amounts of progesterone are produced in the testes and adrenal glands. Progesterone interacts with and mediates estrogen. Progesterone is known as a precursor hormone for estrogen, luteinizing hormone, and testosterone, among others. To a certain extent, progesterone controls the production of these other hormones and can help balance any deficiencies or excesses of them in your body. In addition to helping relieve the symptoms of menopause and PMS, progesterone is known to enhance energy and sexual libido, and to heighten feelings of well-being. Progesterone should not be confused with progestin. Progestin is a synthetic chemical and is unable to synthesize other hormones or help our bodies produce the other hormones it needs to function at



full potential. Progesterone can be administered orally (powder or micronized in oil base as capsules, oral drops, or sublingual tablets), vaginally or rectally (with suppositories), through injections or topically with transdermal creams or gels.

Testosterone Replacement Therapy (TRT)

Testosterone, although a primary male hormone, also plays a role in women's health. A decline in testosterone levels in men may be indicated by symptoms including loss of libido, erectile dysfunction, deterioration in ability to concentrate, poor muscle tone and strength, lack of endurance and mood swings. A decline in testosterone levels in women may accompany a decreased libido, irritability, weight gain, loss of lean muscle and osteoporosis. Testosterone contributes to higher energy levels and overall sense of well-being, increases lean body mass, and helps in building strong bones.

For people not producing high enough levels of testosterone, Testosterone Replacement Therapy (TRT) may be appropriate. This therapy should be considered when hormone deficiency has been clinically proven through laboratory testing of blood serum or saliva.

Testosterone can be administered orally, topically (through creams or gels), or via pellet implant (which is a pellet placed underneath the skin) or injectable. The oral route is not considered to be a primary method of delivery. Topical application of testosterone is usually the preferred method for TRT. AnazaoHealth offers

testosterone creams, gels, pellets and injectables in a variety of strengths. There are different advantages associated with different dosage forms, so the physician should discuss with the patient to identify the appropriate dosage form that would most effectively promote patient compliance.

Hormones for Men & Women

- **DHEA** – An adrenal cortex steroid hormone that raises levels of sex hormones and has been linked to increased lean body mass, improved immune and cognitive functions and skin tone.
- **Estrogens** – The primary female hormones consisting of Estradiol / Estrone/ Estriol – Biest or Triest.
- **Melatonin** – Helps regulate a good sleep/wake cycle and is recognized as a powerful free radical scavenger.
- **Pregnenolone** – a steroid hormone produced by the adrenal glands and synthesized directly from cholesterol. It is a precursor hormone, from which all other steroid hormones are made.
- **Progesterone** – An ovarian hormone that helps maintain menstrual cycles, PMS and mediates other hormones.
- **Testosterone** – The primary male hormone.
- **Thyroid** - the thyroid gland secretes two hormones, T3 and T4 which helps to regulate metabolism. The thyroid-stimulating hormone (TSH) is produced by the pituitary gland which prompts the thyroid to produce T3 and T4.

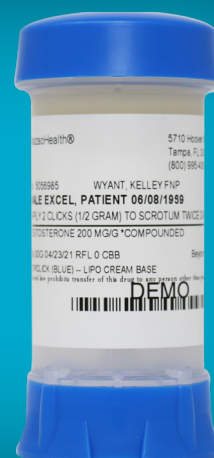

Pellet Implantation

Hormone replacement therapy in pellets are placed beneath the skin, typically in the buttocks or abdomen, to provide a reservoir for your patient. Implanting the grain-of-rice-sized pellets takes about five minutes and should be repeated every four to six months. Pellet implantation offers stronger patient compliance due to not having a daily regimen of hormone dosing.

Special machined techniques eliminate virtually all variability pellet to pellet. Every pellet is independently weighed and visually inspected to meet defined acceptance and release criteria.

Most pellets typically have a 1-year Expiration Date from the date they are compounded, allowing peace of mind when ordering for office use, to stock inventory for your practice. Most Testosterone Cholesterol Pellets have 180 days dating from the date they are compounded.

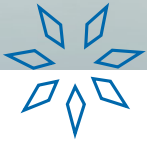

Erectile Dysfunction Solutions

Erectile dysfunction (ED), sometimes called “impotence,” is the repeated inability to achieve and maintain an erection of sufficient rigidity for satisfactory sexual intercourse.

First-line therapy for ED is the use of oral drugs called phosphodiesterase (PDE) inhibitors. These drugs do not create immediate erections but require sexual stimulation to attain an erection. However, oral formulations may not work for approximately 30% of the patients taking them. Patients who are not responding to first-line therapy may be offered second-line therapy.

Second-line therapy for ED is the use of Intracavernous Injection (ICI) therapy. Medications are injected in the corpora cavernosa, the erectile cylinders of the penis. ICI therapy is an effective treatment with high success rates of 85%. Injection therapy can be given as a single agent (monotherapy) or a multi-agent mixture such as Bi-mix, Tri-Mix, and Super Tri-Mix.

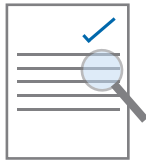
